# STALLION SERVICE CONTRACT

## SHIPPED FROZEN SEMEN



THIS Stallion Service Agreement is made and entered into this day and month written below between, CHAR-O-LOT RANCH (“Stallion Owner”) and \_\_\_\_\_ (“Mare Owner”). These parties agree as follows:

- Mare Owner agrees to breed the mare (“Mare”) \_\_\_\_\_

 to **THE HUNTER** standing at CHAR-O-LOT RANCH, 35750 SR 70 E, MYAKKA CITY, FLORIDA for the 2020 season and to pay the Stallion Service Fee together with other reimbursable expenses set forth herein.
- The Stallion Service Fee \$1,250.00, which is due in full before semen can be shipped.  
**A Visa or Mastercard account number is required for Federal Express freight, insurance and deposit on Frozen semen cannister.**
- The Stallion Service Fee shall include the following:
  - Breeding Fee and the first shipment of 2 doses of semen.
  - All shipping charges, both to receive semen shipment and to return the frozen semen tank are the responsibility of the mare owner. Frozen semen only.**
- Subsequent Shipments. For each shipment following the **first shipment**, the Mare Owner shall be responsible for the following:
  - \$400.00 for 2 additional doses of semen, plus any charges for Federal Express freight, insurance and deposit on Frozen semen cannister.
  - If same day service is necessary, there will be an additional \$300.00 airport courier fee assessed.
  - All additional charges and/or unpaid balances shall be automatically billed to your credit card unless otherwise agreed upon in advance by both parties. Charges may include but are not limited to semen charge, airport courier fees, federal express freight and airline freight charges.
- Mare Owner shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, Mare Owner will hold Stallion Owner harmless.
- The breeding season for frozen semen begins February 1st and closes June 15th at which time all shipments will be discontinued.
- If the mare does not settle in 2020, the Stallion Owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only (2020 season). In 2021, the Mare Owner has two options:
  - Mare can be brought to Char-O-Lot Ranch, Myakka City, Florida for service, provided the Mare Owner is responsible for all additional charges other than the service fee, **OR**
  - Mare Owner may again ship additional frozen semen for a fee of \$500.00 per each 2 mare doses shipped. Each shipment will incur normal fees, in accordance with the Stallion Owner’s then current policies.
- Stallion Owner guarantees live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance. Mare Owner shall notify Stallion Owner in writing within one week of foaling date (or the date the Mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a licensed veterinarian verifying that the foal is not “live” as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed:
  - Stallion Owner shall give to Mare Owner (1) one season to the Stallion, per the terms of Paragraph 7, the following year only and to the same Mare originally booked.
  - If Mare Owner fails to deliver the Mare for rebreeding the following year, then any and all fees paid shall not be refundable; the right to rebreed is thereby canceled and Stallion Owner is released from any further obligation.
- The parties agree that should the above named stallion die or semen become unfit for service, the mare owner shall be entitled to substitute the above stallion with another stallion owned by the Stallion Owner.
- This contract shall not be transferable by Mare Owner. A Breeders’ Certificate will be issued with the Mare Owner notifies the Stallion Owner of the birth of the foal and only after payment of all bills due on the Mare have been received. This agreement constitutes the entire agreement between the parties; any amendment to or modification of the terms of this agreement must be in writing.
- Should it be necessary for the Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all reasonable attorney’s fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
