This Stallion Service Agreement is made and entered into the day and month written below by and between Char-O-Lot Ranch, as the Stallion Owner and Stallion Manager

1.	Mare Owner agrees to breed the mare ("Mare")

	to <b>JOHN WICK</b> , standing at CHAR-O-LOT RANCH, MYAKKA CITY, FLORIDA for the 2025 season and to pay the Stallion Service Fee, together with other reimbursable expenses as set forth herein.				
2.	The Stallion Service Fee shall be \$550.00. There is not a chute fee charged for on-farm bred ma	ares, this fee is included in the	Char-O-Lot Ranch Breeding Package	Fees	

- The Stallion Service Fee shall be \$550.00. There is not a chute fee charged for on-farm bred mares, this fee is included in the Char-O-Lot Ranch Breeding Package Fees as detailed below. The Stallion Service Fee must be paid before the Mare can be bred.
- 3. The 2025 Breeding Package Fees for board and breeding services are:

Dry Mares \$1,700.00 per month, inclusive of ordinary and customary breeding expenses and chute fees Wet Mares \$1,900.00 per month, inclusive of ordinary and customary breeding expenses and chute fees

("Mare Owner"). The parties agree as follows:

Note: The package fees are detailed on the attached Schedule. Please review the Schedule for a complete list of the services included and excluded from the package fees. A deposit of \$500.00 will be due upon the Mare's arrival at Char-O-Lot Ranch, which will be applied to the first monthly invoice. All board and expenses on mare and/or foal shall be paid monthly and are due upon receipt of invoice. Interest at the rate of 18% per annum will be charged on all invoices not paid within 30 days. All unpaid board and expenses shall be paid when the Mare is picked up from CHAR-O-LOT RANCH. The Mare will not be released to the Mare Owner or their representative until all fees including the Stallion Service Fee are paid in full.

- 4. The Stallion Manager will exercise judgment consistent with recognized standards in the care and supervision of Mare and/or foal. The Stallion Manager assumes responsibility, in its discretion, for arranging veterinarian and farrier services as necessary. Mare will be examined for normal breeding conditions and administered medical care as deemed necessary for the health and safety of the Mare and/or foal. All veterinary expenses and all farrier expenses will be paid by the Mare Owner.
- 5. The Mare shall be in a healthy and sound breeding condition, free from infectious, contagious, or transmissible disease. A current negative Coggins Test, photostat copy of registration papers (both sides), plus a health, worming and immunization record must accompany Mare. If they do not, the Stallion Manager's veterinarian will examine and/or test Mare at the Mare Owner's expense. The Stallion Manager reserves the right to refuse Mare if not in satisfactory condition.
- 6. The Stallion Owner or Stallion Manager shall not be liable for injury, sickness or death of the Mare and/or her foal, regardless of how it may occur. Likewise, the Mare Owner shall not be liable for disease, injury or death to the stallion arising out of the services contracted for in this agreement.
- 7. The Stallion Manager shall attempt, with reasonable diligence, to settle Mare. If, however, for any reason the Mare does not settle, Mare Owner will hold Stallion Owner harmless. The breeding season for the stallion begins February 1st and closes June 15th, at which time all breeding will be discontinued. If the mare does not settle in 2025, the Stallion Owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only the 2025 season. Any applicable booking fees will be charged.

#### 8. IF MARE LEAVES PREMISES PRIOR TO 21 DAY ULTRASOUND, RE-BREEDS WILL NOT BE HONORED

- 9. Stallion Owner guarantees live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance, Mare Owner shall notify Stallion Owner/Manager in writing within one week of the foaling date (or the date the Mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a veterinarian verifying that the foal is not "live" as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified it is agreed:
  - a. Stallion Owner shall give to Mare Owner (1) one free season to the Stallion, per the terms of Paragraph 7, the following year **ONLY** and to the same Mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner).
  - b. If Mare Owner fails to deliver the Mare (or a substitute Mare is mutually agreed upon as stated above) for re-breeding the following year, then any and all fees paid shall not be refundable; the right to re-breed is thereby cancelled and Stallion Owner is released from any further obligation whatsoever.
- 10. This contract shall not be transferable by Mare Owner without the prior written consent of Stallion Owner. A Breeder's Certificate will be issued when the Mare Owner notifies the Stallion Owner of the birth of the foal and only after payment of all bills due on the Mare have been received.
- 11. Embryo Transfers. If more than one (1) embryo is obtained from a single flush, an additional breeding fee(s) must be paid in order to receive additional Breeders' Certificate(s). This contract is for one (1) Breeders' Certificate only. Semen to be utilized in Intracytoplasmic sperm injection procedures will require a separate contract.
- 11. This agreement constitutes the entire agreement between the parties; any amendment to or modifications of the terms of this agreement must be in writing. Should it be necessary for Stallion Owner/Manager to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all reasonable attorney's fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
