## STALLION SERVICE CONTRACT

### JOHN WICK-Shipped Cooled Semen

This Stallion Service Agreement is made and entered into the day and month written below by and between Char-O-Lot Ranch, as the owner and Stallion Manager (the "Stallion Manager" or "Stallion Owner") and \_\_\_\_\_ ("Mare Owner"). The parties agree as follows:

1. Mare Owner agrees to breed the mare ("Mare") \_\_\_\_\_

to **JOHN WICK**, standing at CHAR-O-LOT RANCH, MYAKKA CITY, FLORIDA for the 2025 season and to pay the Stallion Service Fee and other reimbursable expenses set forth herein.
2. The Stallion Service Fee shall be \$1,000.00, which includes a Booking Fee of \$450.00 and will reserve the mare owner a breeding by means of cooled shipped semen for the 2025 breeding season. Before shipment of semen, the stallion service fee plus the booking fee must be paid in full. With respect to the shipment of semen, the following fees shall apply:
  - a. **Initial Shipment.** The collection fee for the first shipment is included in the initial Booking Fee, provided the shipment is requested on a regular breeding day (Monday, Wednesday, Friday) and the breeding farm is notified prior to **9:00 A.M.** Eastern Time on the day semen is shipped. The shipping charge for the first shipment shall be an additional flat fee of \$250.00 and shall be paid prior to or at the time of shipping.
  - b. **Subsequent Shipments.** Each subsequent shipment, provided the shipment is requested on a regular breeding day (Monday, Wednesday, Friday) and the breeding farm is notified prior to **9:00 A.M.** Eastern Time on the day semen is shipped, inclusive of shipping, will be a fee of \$500.00 which shall be paid prior to or at the time of shipping
  - c. **Off Breeding Day Shipments.** Any shipments requested on days other than Monday, Wednesday, Friday, including the initial shipment, will be charged an additional fee of \$200.00.
  - d. **Courier Fees.** If a shipment requires a courier fee to an airport for shipping, courier fees will be charged based upon the cost incurred.
  - e. **Payment Requirements.** The Stallion Manager requires Mare Owner to provide a credit card number for the initial shipping charge and any subsequent shipments to Mare Owner. All additional charges and/or unpaid balances shall be automatically billed to your credit card unless otherwise agreed. Charges may include but are not limited to shipment fees, off day charges, and courier fees.
3. The Stallion Manager shall not be responsible for the cost arising from shipments lost, damaged or delayed in transit, or the condition of cooled semen upon delivery. We have no control of the shipment after it leaves our custody.
4. With respect to semen orders, priority is given to mares on farm, next for orders in the order they are received (except that first time shipments are given priority over subsequent shipment requests). Semen orders can be made prior to the shipment day and then confirmed before 9:00 AM on collection day to be placed on the list earlier.
5. The Stallion Manager will use Equine Express Shippers weather permitting. Hamilton-Thorne Equitainers are also available upon request. The Mare Owner agrees to return the Equine Express Shipper or Equitainer within a seven (7) days, and all shipping charges to return the Equine Shipper or Equitainer to Char-O-Lot Ranch are the responsibility of the mare owner.
6. The Mare Owner shall attempt with reasonable diligence to settle the mare; if however, for any reason the mare does not settle, the Mare Owner will hold the Stallion Owner and manager harmless.
7. The breeding season for shipped semen begins FEBRUARY 1ST and closes JUNE 15TH at which time all shipments will be discontinued.
8. If the mare does not settle in 2025, the Stallion Owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only the 2026 season. The Booking Fees and all additional shipment and collection fees will be charged.
9. The Stallion Owner guarantees live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance. Mare Owner shall notify Stallion Owner in writing within one week of foaling date (or the date the Mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a licensed veterinarian verifying that the foal is not "live "as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed;
  - a. The Stallion Owner shall give to the Mare Owner (1) one season to the Stallion, per the terms of Paragraph 8, the following year only and to the same Mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner).
  - b. If the Mare Owner fails to deliver the Mare for rebreeding the following year, then any and all fees paid shall not be refundable; the right to rebreed is thereby canceled and Stallion Owner is released from any further obligation.

11. This contract shall not be transferable by Mare Owner. A Breeders' Certificate will be issued with the Mare Owner notifies the Stallion Owner of the birth of the foal and only after payment of all bills due on the Mare have been received. This agreement constitutes the entire agreement between the parties; any amendment to or modification of the terms of this agreement must be in writing.
12. Should it be necessary for the Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all reasonable attorney's fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
13. Embryo Transfers. If more than one (1) embryo is obtained from a single flush, an additional breeding fee(s) must be paid in order to receive additional Breeders' Certificate(s). This contract is for one (1) Breeders' Certificate only. Semen to be utilized in Intracytoplasmic sperm injection procedures will require a separate contract.
14. It is further agreed that should the stallion die or become unfit for service, this contract shall become null and void, and any money paid as part of the stallion service fee less the nonrefundable booking fee & shipping/collection fees, shall be refunded to the mare owner.
15. Canadian shipments require an additional form to be completed and additional shipping fees apply.
16. **REQUIREMENT PRIOR TO SHIPMENT:**
  - a. Original Signed Contract with Stallion Service Fee.
  - b. Booking Fee.
  - c. Fully completed Detailed Information Sheet (attached)
  - d. Copy of Mare's Registration Papers (both sides)
  - e. Credit Card Number
